

MEETING MINUTES OF THE GOVERNING BOARD OF WEST40 INTERMEDIATE SERVICE CENTER #2

The West40 ISC #2 Governing Board Meeting was held on Friday, September 20, at 8:00 a.m., at 415 Lexington Street, Maywood, IL 60153. Board President Dr. Kelsall called the meeting into order at 8:02 a.m.

III. Presentations

Communications Department - Director Heidi Bellm

Ms. Bellm introduced the Communications Department as wanting to change the conversation around education and increase awareness around the topics that impact education. The department is helping local school districts and community agencies tell their stories by creating infographics and video recordings.

Ms. Bellm also introduced West40's new digitized branding kits to help understand the mission and vision of the West40 programs.

Ms. O'Hara introduced the West40's new Employability Pathway Partners program, which emphasizes moving students beyond internship into employability. The program will allow students to explore careers early and build skills and traits that will position students as strong candidates for internships or apprenticeships during high school, college, or post-graduation to ensure each student has a clear career path upon graduation. This is made possible by local and national partnerships that help build many opportunities.

Financial Report - Ms. Christi Tyler:

Ms. Tyler reported that August marked the first payments of EBF, an additional \$396,126 each month. On the expense side, there was a decrease in capital projects as the HVAC and demolition work at St. Joseph's was completed.

West40 continues to wait for the \$4M reimbursement payment from DCFS.

The work of managing EANS funding is slowly coming to an end. Non-public schools must have all their purchasing completed and invoiced by January 15, 2025.

West40 will be expanding the fiscal work with Philip Rock Center.

Assistant Executive Director Report Dr. Jayme Tighe

Dr. Tighe celebrated that West40 is operating under year 4 of 5 of the strategic plan. Cabinet meetings remained focused on completing action plans and driver-providing updates.

Dr. Tighe highlighted that Senior Directors Ms. Renee Makris and Mr. Joe Gage's presentation of the Alternative Learning Opportunities Programs (ALOP) at the Illinois Association of Regional Superintendent of Schools (IARSS) was a great success. Thus far, 13 regional offices of education

and the Intermediate Service Centers (ISC) have launched ALOP programs in their school districts.

The Comprehensive Educational Services (CES) department is working with the STAT team to finalize the emergency operations plan for the West40 Lexington campus.

Coming up to year 5 of the strategic plan is developing internal and external stakeholder surveys that will be administered in the Spring. The surveys will have two pathways, one for those with ties to West40 since the strategic plan was implemented and the second for those new to West40.

This year, twelve internal promotions were made. BMV is working to expand the Potential Leader survey across the organization to be equitable in identifying and supporting potential leaders.

During Year 5 of the strategic plan, West40 will develop a systematic continuous improvement process that can be replicated statewide. Currently, West40 is supporting 140 CPS schools. The focus is to continue the work with ISBE on the ESSA plan, prepare for Illinois Empower, and learn how ISCs and ROEs can support that work. On October 30, 2024, approximately 30 additional schools will be added. ISBE has agreed to support that work by adding four additional school improvement educators.

Executive Director Report - Dr. Mark Klaisner

Dr. Klaisner seconded Dr. Tighe's updates and celebrated the organization's remarkable growth, including launching ALOP programs statewide.

The Comprehensive Education Services team continues to support local school districts and nationwide municipalities.
